Content	This class is designed to address the main contours of environmental policy in Turkey and in the world. It starts with a discussion on why we need the environmental policy at all. After establishing the necessity of environmental action and policy at the local, national and global level, five main elements of environmental policy making are reviewed: i) prescriptive regulation, ii) property rights, iii) penalties, iv) payments and v) persuasion. The course also explores a variety of approaches to environmental policy in the world and focuses on case studies with various scales from global to regional/supranational, national, and local.
Objectives	Enabling students establish the connections between environmental issues and policymaking Ensuring the fluency about the main elements of environmental policy making in Turkey and the world Aspiring students to be able to critically analyze actual policy initiatives in the world Ensuring that students can design their own research agendas and generate valuable and relevant research projects in this field.

İçerik	Bu ders Türkiye'deki ve dünyadaki çevre politikasının ana hatlarını ele almak için tasarlanmıştır. Ders, çevre politikasına neden ihtiyacımız olduğuna dair bir tartışma ile başlar. Yerel, ulusal ve küresel düzeyde, çevresel eylem ve politikanın gerekliliğini belirledikten sonra, çevre politikası oluşturmanın beş ana unsuru gözden geçirilir. i) kuralcı düzenleme, ii) mülkiyet hakları, iii) cezalar, iv) ödemeler ve v) ikna. Dünyadaki çevre politikası yaklaşımlarının çeşitleri irdelenip, küreselden bölgesel / uluslar üstü, ulusal ve yerel ölçeklere kadar çeşitli ölçeklerde vaka çalışmaları ele alınmaktadır.
